6. That I/we have never been externed from my place of stay by any judicial authority and neither am I a proclaimed offender of any state Govt. or of Delhi Police, and to the best of my knowledge there is no Red Corner Notice or any other Look Out notice pending against me.
7. That I/we have also no proceedings/cases instituted against me in the CBI, NCB, Enforcement Directorate, Directorate of Revenue Intelligence, Income Tax and Forest Department pending against me.
8. That I/we have also not been arrested, deported or involved in any illegal act in any other country where I have visited or resided.
9. That I/we have any/no permanent/temporary petroleum license issued from any state in India. If yes give details and attached documents in this regard.
10. That I/we have applied for petroleum product license previously \_\_\_\_\_ times. (If yes enclosed copy of earlier license issued in favor of the applicant or the proposed premises.)
11. That I/we have submitted following documents: -
  - Four copies of site plan duly approved by the Chief/Jt. Chief Controller of Explosives.
  - Application on Form –IX of the Petroleum Rules, 2002 for the grant of petroleum license/NOC.
  - Application on Form–C of The Gas Cylinder Rules, 2004 for the grant of NOC for installation of CNG Dispensing unit.
  - Application on Form–I-A of The Static and Mobile Pressure Vessels (Unfired) Rules, 1981 for the grant of NOC for installation of LPG Dispensing unit as automotive fuel.
  - Land owning documents in case of dispensing stations.
  - Contract agreement if any.
12. That I/we will be utilizing the NOC within a period of one year from the date of issue failing which it shall be deemed to have lapsed.
13. That I/we will obtain the Petroleum products license from Licensing Authority (Chief Controller of Explosives), as the case may be.
14. That I/we will not use in any manner or any other storage of Petroleum

- product or for any other installation of Petroleum outlet on the same premises.
15. That I/we will follow the conditions, which may be imposed, by the Chief Fire Officer or any other authority from time to time will have to be observed strictly.
  16. That I/we will do nothing in contravention to the conditions as laid down in Notification No.1028 dated 27 Sep. 2005 issued by DDA.
  17. That I/we will do nothing in contravention of the Petroleum Rules, 1976 as modified upto 1<sup>st</sup> January, 1981 Chapter-V, Rule-117 read with comments of the Chief Inspector of Explosives thereof.
  18. That I/we will display 'No Smoking' sign board both in Hindi and English in such a manner as to be easily readable by all persons.
  19. That I/we will not allow any susceptible trade to cause ignition petroleum vapours due to generating of heat, mechanical/ electrical spark within the licensed premises.
  20. That I/we will install minimum two Mechanical Foam Fire Extinguishers of 9 litres capacity each duly having ISI certification mark//minimum \_\_\_\_\_Nos of Dry Chemical Powder (DCP) as specified in OISD-179 and six buckets filled with dry loose sand and maintain in good working order or as per directions issued by the various authorities.
  21. That I/we will install minimum one Co2 fire extinguisher of at least 4.5 kg capacity duly ISI marked to combat any electrical fire risk or as per directions issued by the various authorities.
  22. That I/we will undertake that the workers/ employees at the site must be taught the correct method of operation and maintenance of record of the fire extinguishers be maintained and entry to the area should be restricted for others.
  23. That I/we will not allow overhead electric wires/ cables and loose/naked wiring across the licensed premises in contravention of Indian Electricity Rules.
  24. That I/we will provide fencing/boundary wall around the premises to isolate it from thoroughfare.
  25. That I/we will undertake that no trade other than the applied trade be done in the premises.
  26. That I/we will undertake that the Petroleum products are only for the captive use for the activities performed in the premises.
  27. That I/we will undertake that no obstruction to the smooth flow of traffic/ other road users and the visitors will park their vehicles in the parking and follow all the rules and regulations for safe and smooth flow of traffic.
  28. That I/we will obtain the final clearance from the fire department before commissioning the storage tanks.
