

SAFETY NORMS:

1. The Licensee shall provide the following life saving devices in adequate numbers –First Aid Box, Oxygen Cylinder, Breathing equipments (Artificial Respirator) , Buoys for beginners (at least two),Life jackets , Life belts, Stretcher etc
2. The licensee shall provide adequate number of life guards.
3. The licensee shall provide sufficient number of guards at the pools both during operational and non operational time to regulate access.
4. The licensee shall provide a qualified instructor /coach who has adequate knowledge of the first aid and artificial respiration.
5. The licensee shall not allow any person who does not know swimming or is beginner to enter the water in the absence of a qualified instructor
6. The licensee shall not allow any person below the age of 8 years to enter the waters unless accompanied by an adult person.
7. The licensee shall provide a qualified doctor at the pool during the operational hours.
8. The Licensee shall place a life saving instructions chart at the pool.
9. The Licensee shall place the safety/sanitary rules board at the pool.
- 10.The licensee shall also provide necessary fire fighting appliances in the premises which must be maintained in proper condition.
- 11.The licensee shall provide adequate lighting in the period the pool is kept open to the public
- 12.The licensee shall not allow undesirable elements in the vicinity of the pool and shall take adequate precautions against eve teasing.

HYGIENE STANDARDS

1. The licensee shall not allow more than 40 persons (beginners) in the shallow and 5 persons in each lane of 2.5 mtrs width in a full sized pool ie .50 mts X 21mts. In smaller pools 20 persons are allowed in the shallow and 3 persons in each lane.

2. The licensee shall keep the water in the pool clean and change it atleast once a month and at short intervals if directed. Monthly water test report shall be submitted to the licensing branch.

3. The licensee shall provide separate bathrooms and dressing rooms for males and females in such number and in such dimensions as may be prescribed by the licensing authority

4. The Licensee shall provide and maintain showers in the bathrooms

5. The licensee shall not allow any person –

- To enter the pool if he/she has not taken a shower bath and a foot bath in the bathroom provided on the premises
- To enter the pool in any apparel other than the recognised swim ware or the costume trunk
- Either before or after entering the water of the pool to use soap , oil , or any substance or preparation whereby the water of the pool may be rendered turbid or unfit for use of the bathers
- Wilfully or otherwise foul or pollute the water of the pool by spitting or in any other matter whatsoever
- Suffering from skin disease, venereal disease, or any other contagious disease to use the pool.
- To enter the pool or remain in the pool at any time other than prescribed under the regulations or enter or remain on the premises surrounding to the swimming pool fifteen minutes before or after the opening and closing hours.
- Any animals to enter the swimming pool or the Premises surrounding to the swimming pool thereto.
