## AFFIDAVIT

2. I undertake that the eating house is running as per the norms of Master Plan prevailing at the time. I also undertake that it will not violate the provisions of MPD-2021. That this Eating House has been running from the above premises for the last ..... months/years. 3. That I/my Company have no criminal proceedings/cases instituted against me in India or abroad till date and I/my company fall in the category of "suitable person/company as defined in "Delhi Eating Houses Registration Regulations, 1980". (Details of decided cases, if any, is also to be given)

That I have never been externed from my place of stay by any judicial authority and neither am I a proclaimed offender of any State Govt. or of Delhi Police and to the best of my knowledge there is no Red Corner Notice or any other Look Out Notice pending against me. 5. That I am organizing/not organizing/will not organize/organize amusement activity in the Eating House/Restaurant/Shop under The Regulations for Licensing & Controlling places of public Amusement (other than Cinemas and performances for public Amusement, 1980).

6. All Safety measures in the interest of public as per the norms prescribed by all Deptts. are in place and that the place and locality are also suitable as required in the "Delhi Eating Houses Registration Regulations, 1980" and MPD-2021.

7. I have taken adequate safety measures regarding fire fighting arrangement in the premises. Staff deployed in Eating House have adequate knowledge to use fire fighting equipments.
