EXISTING EATING HOUSES**

2.	<p>Proof of ownership/tenancy/lease of premises of the Eating Houses, (registered sale deed, registered lease/rent deed),</p> <p><b>(required if not submitted in the past and if changes have been effected)</b></p>
3.	<p>Certificate of Incorporation of Proprietorship, LLP, Partnership, Limited, Private Ltd., Public Ltd., Company.</p> <p><b>(required if not submitted in the past and if changes have been effected)</b></p>
4.	<p>Names of Directors &amp; Current DIR – 12 &amp; Board Resolution for conducting business; Nomination of Authorised signatory/ partners, on letter head,</p> <p><b>(required if not submitted in the past and if changes have been effected)</b></p>
5.	<p>Prescribed Affidavit for Eating House License.</p>
6.	<p>Fire Safety Certificate from Delhi Fire Service, if the eating house has covered area of 90 sq. m. or more.</p> <p align="center">OR</p> <p>The following information, if the eating house has covered area less than 90 sq. m.:</p> <ol style="list-style-type: none"> <li>1. 7.	<p>The following minimum fire safety measures shall be taken by the applicant, if the eating house has a covered area less than 90 sq. m:</p> <p>a) Automatic fire-suppression system viz. fire sprinkler system, gaseous fire suppression, and condensed aerosol fire suppression should be installed in the kitchen</p> <p>b) Adequate number of portable fire extinguishers should be kept at appropriate locations</p> <p>c) Exhaust systems should be installed</p> <p>d) Inflammable material should be stored in a safe place away from the public area</p> <p>e) Fire alarm systems should be installed</p> <p>f) Adequate number of fire/emergency exits duly marked should be provided.</p> <p>g) The passages should be kept free from any obstruction, hindrance and temporary features</p> <p>h) The fire/emergency exits should be kept clear and free from any obstruction, hindrance and temporary features</p>

9.	<p>GST Registration Certificate in the name of Eating House/Company,</p> <p><b>(required if not submitted in the past and if changes have been effected)</b></p>
10.	<p>Registration Certificate under Shops &amp; Establishment Acts, issued by Labour Department, GNCT of Delhi,</p> <p><b>(required if not submitted in the past and if changes have been effected)</b></p>
11.	<p>FSSAI Certificate,</p> <p><b>(required if not submitted in the past and if changes have been effected)</b></p>
12.	Photocopy of Excise License in case of operational Bar.
13.	<p>Does the Establishment permits/ proposes to permit smoking in the premises.</p> <p>Note: Eating Houses with seating capacity below 30 seats are not permitted to provide smoking zone.</p> <p>If no, furnish affidavit on the prescribed format declaring that the Establishment is a</p>

	complete no smoking area.  If yes, details of space earmarked for smoking in terms of G.S.R. No. 500(E) dated 23rd May, 2017, (COTPA Act 2003).
14.	DPCC Consent Letter. In case of old establishments i.e established before 2012, the subject tariff revision is under consideration of competent authority, if the applicant is not able to produce the consent letter at the time of application, provisional renewal will be allowed subject to the condition that the applicant complies with the pollution control norms and he/she shall furnish the same within the stipulated time granted by this authority.
15.	Proof of AMC of CCTV system with 30 days recording.
16.	List of all employees with name, parentage & address along with Police Verification Certificate or proof of submission thereof in jurisdictional Police Station.

- # All photocopies be self-attested by applicant
- # NOC/ Affidavit/ undertaking/ Indemnity Bond should be given on a stamp paper of Rs. 10/-.
- # The Licensing Authority may require production /submission of additional documents, if so required.
- # The applicant should clearly mention in the affidavit, whether the applicant will also hold amusement activities such as Live Band, DJ, Discotheque etc. and should undertake to obtain separate licence/s under relevant regulations.
- # The applicant should clearly mention in the affidavit, whether the applicant will also operate a Bar and should undertake to obtain separate licence under the Delhi Excise Act, 2009.
- # The applicant should submit a self-attested affidavit if the applicant entity's annual turnover is less than Rs. 20 lac and is exempted from registration under the GST Act, 2017.
